#### A. THE COMMISSION

The J. William Fulbright Commission for Educational Exchange in the Slovak Republic is a bi-national, not-for-profit organization, whose mission is to promote mutual understanding and cooperation between the people of the United States of America and the Slovak Republic through educational and cultural exchanges.

The Commission was established by an executive agreement between the Government of the Slovak Republic and the Government of the United States of America in 1994 (319/1994 Coll.) The subsequent agreement signed in 2005 (98/2005 Coll.) was amended in 2017 (303/2017 Coll.). In 2017, the Slovak authorities started issuing national visas to Fulbright scholarship recipients and their dependents who have been exempted from visa fees since.

The main responsibilities of the Commission as follows:

- administer grants and fellowships for U.S. and Slovak nationals to study, research, or lecture;
- identify and select the best candidates in both countries and engage them in academic exchanges within the highest standards of the Fulbright Program;
- identify fields in which mutual cooperation is desirable to further develop and increase expertise in particular fields;
- extend activities by establishing and supporting cost sharing programs with participating institutions;
- spread awareness and provide information about study and research opportunities in the United States.

In addition to the administration of the Fulbright Program, the Commission is the only official institution in Slovakia certified to provide accurate, comprehensive, and current information about studies in the U.S. through its educational advising center EducationUSA, which is part of the worldwide educational advising network of the U.S. Department of State.

The Fulbright Commission is governed by the bi-national **Board of the Commission** which oversees the operation and activities of the Commission. The Minister of Education, Science, Research and Sport of the Slovak Republic appoints Slovak Board members and the U.S. Ambassador to the Slovak Republic appoints American Board members. Both serve as Honorary Co-Chairpersons of the Board of the Commission.

The Board has the responsibility for setting long term goals and priorities of the program, program activities, selection and nomination of grantees, and coordination of finances of the Commission.



#### B. FULBRIGHT AWARDS

The Commission administers a variety of awards for both U.S. and Slovak citizens based on an open, merit-based competition and takes into account recommendations of selection committees focusing on professional skills, academic achievements, financial means available, and other program requirements; and announces the final nomination of Fulbright grantees.

The academic year 2021-22 continued to be affected by Covid -19 pandemic. Due to the global suspension of the Fulbright Program in 2020, the academic year 2021-22 had a combined cohort consisting of deferred grants from the academic year 2020-21 and the newly selected grantees in the respective year. Above mentioned resulted in the increase of grants in the academic year 2021-22. The total number of participants in Fulbright programs administered by the Commission reached 34 (20 deferred from AY 2020-21).





# 1. Fulbright Student Program

Slovak and U.S. graduate students can apply for 6 to 9 month scholarships to carry out independent research or study at Slovak or U.S. institutions, respectively. Candidates are required to prove an outstanding university record and to submit high-quality and well-conceived projects.

Slovak applicants may conduct an independent research, and if funding available, enroll in Master's programs. Fulbright Slovak Student Program is open to any field except for clinical medicine, M.BA and LL.M. Candidates without prior extensive U.S. study experience are given preference.

U.S. applicants can pursue individual research projects under tutorial of a Slovak expert in the respective field. Knowledge of Slovak language is desirable for commensurate with the level needed in fields like political science, history, linguistics, and anthropology.

The applications are welcomed in any field; although preference may be given to the needs of Slovak academic institutions. Candidates without extensive research or lecturing experience in the Slovak Republic are given preference.

Slovak scholars who hold a Ph.D. degree (in arts and some other fields comparable professional experience is required) must include an invitation letter from the U.S. institution in their application. All areas of research or lecturing, except clinical medicine, are eligible. Candidates without prior extensive U.S. research or study experience are given preference.

# 4. Fulbright Specialist Program

Slovak academic institutions can invite a U.S. expert for 2 to 6 weeks to lecture, assist in developing curricula and educational materials, participate or lead seminars and/or workshops, etc.

The program is a short-term complement to the traditional Fulbright Scholar Program. It attracts those U.S. experts who otherwise would not be able to participate in one or two semester program.

#### 5. Fulbright Scholar-in-Residence (S-I-R) Program

Scholar-In-Residence Program assists U.S. higher education institutions in expanding academic exchange programs. By supporting non-U.S. Scholars through grants for teaching at institutions with no strong international component, both the U.S. institution and the scholar grantee benefit.

#### 6. Inter-Country Travel Grant

Commission received and supported one ICT grant of **Professor Mary Jo ONDRECHEN**. During her stay at the Budapest University of Technology and Economics in Hungary, prof. Ondrechen was requested by the Department of Computer Sciences of Comenius University to give a lecture on "Using Chemistry to Understand Genomic Data" to an audience involving researchers and students interested in computational biology, genetics, biochemistry, and other related disciplines. The lecture took place from November 23 – 25, 2022.

#### 7. Fulbright Teaching Excellence and Achievement Program

The Commission has launched the Fulbright TEA Program in Slovakia. The program will bring international secondary-level teachers to the United States for a six-week professional development opportunity to take academic seminars at a host university, observe and share their expertise with U.S. teachers and students, and develop action plans to promote media literacy and critical thinking skills in their home schools, classrooms, and communities. The program's Media Literacy Cohorts will include content-specific coursework with a focus on media literacy and critical thinking classroom skills.

Teachers are nominated to participate in the Fulbright TEA Program Media Literacy Cohort based on their educational experience, academic training, leadership, and professional experience.

To promote the program and recruit Slovak teachers, the Commission organized two information webinars (February 17 and March 8, 2022) with an overall attendance of 167. The Commission received 14 applications of which the Fulbright Commission pre-selected 7 top candidates that were invited for the virtual interviews taking place on April 13, 2022 via Zoom. The selection committee has nominated 4 candidates for final selection made by the U.S. Department of State. The Department of State selected three teachers: Ms. Lenka **ZGÚTOVÁ** (principal candidate), Daniel **GONOS** (principal candidate), and Natália GETTLEROVÁ (alternate candidate).



#### C. OTHER AWARDS

#### 1. Hubert H. Humphrey Fellowship Program

The program gives opportunity to mid-career professionals to participate in 10-month study and related professional experience at U.S. institutions in fields such as environmental management, finances, human resources management, urban planning, communications, drug abuse education, etc. Final selection of nominees from over 150 countries is made at the U.S. Department of State.

After successful completion of the Humprey Program, Ms. Podlesná received further financial support from the **Alumni Impact Award**. In cooperation with her mentor prof. Connie Sung Ms. Podlesná developed the concept of international public-private partnership (**Profesia Lab**) which may help to bridge disability employment gap in open labor market in Slovakia by using the best practices and knowledge in the employment of people with disabilities from Michigan State University. The main objective of her project is to improve the transition of youth with disabilities from schools to competitive employment settings in Slovakia by implementing the *Assistive Soft Skills and Employment Training* (ASSET program) developed by experts from Michigan State University. The ASSET program will be launched at the conference *Neurodiversity in the workplace* on November 22, 2022 in Bratislava in a partnership with Fulbright Slovakia among others. # 2. Study of the U.S. Institutes (SUSIs)

The Study of the U.S. Institutes are 5-week programs focusing on American Studies and civic society affairs. The candidates are selected through worldwide competition. Fulbright Slovakia, together with the U.S. Embassy in Bratislava, conducted online interviews for two SUSIs programs: SUSIs for Student Leaders and SUSIs for Scholars that were carried out in June and July 2022.

- **Ján Cipár** from the University of Economics in Bratislava stayed at the Michigan State University on the SUSIs on Civic Engagement program;
- Martina Martausová from Pavol Jozef Šafárik University in Košice stayed at the New York University on the SUSIs on U.S. Culture & Values program.

# 3. Ronald and Eileen Weiser Professional Development Award

The Weiser Award (not sponsored by the U.S. Department of State) gives opportunity to Slovak scholars to pursue short-term research visits (4 to 6 weeks) at the University of Michigan, Ann Arbor, USA. Candidates may submit projects in any field of research or teaching with faculty partners at the University of Michigan. These awards are made possible thanks to a gift from Ambassador Ronald Weiser, U.S. Ambassador to Slovakia from 2001-04, and his wife, Eileen Lappin Weiser. There were no Weiser Fellows in the academic year 2021-22 as a result of the suspension of the program due to the COVID-19 pandemic.



#### 4. Cybersecurity Program

Fulbright Poland together with Fulbright Commissions in Bulgaria, Czech Republic, Hungary, Romania and Slovakia as well as partners from the U.S. organized cybersecurity exchange program. The visit, designed for university representatives, was carried out in a hybrid form – combining virtual meetings with an in-person visit to the U.S. East Coast. Two Slovak candidates were accepted and participated in a hybrid form of the program from March 10 to June 23, 2021 - Ing. Boris Bučko, PhD. from Žilinská Univerzita v Žiline, Faculty of Management Science and Informatics, Department of Mathematical Methods and Operations Research and JUDr. Soňa Sopúchová, PhD. from Comenius University, Faculty of Law, Institute of Information Technology Law and Intellectual Property Law.

After the online component, both Slovak participants traveled to the United States for the in-person component of the program in March 2022. Ms. Sopúchová carried out the program from March 12 to 24, 2022 and Mr. Bučko carried out the program from March 26 to April 7, 2022.

#### D. GRANT SUPPORTING ACTIVITIES

Commission carries out different activities throughout the year to support Fulbright programs, Fulbright grantees and alumni, such as recruitment campaigns, selections of candidates for each program, promotional and outreach activities, educational advising, and hosting or supporting events, seminars and conferences, whether online or in-person.

#### • The Orientation Program

Regular orientation seminars are being held for both Slovak and American grantees and are mandatory components of the Fulbright program.

Pre-Departure Orientation Seminar (PDO) for outgoing Slovak grantees was held in-person on June 16,

2022 in order to brief them on important issues related to their departure for the U.S. and the successful completion of their grant. The PDO's main agenda included terms and conditions of the Fulbright and Humphrey awards, visa application, health insurance and financial aspects of the award. Representatives of the U.S. Embassy in Bratislava, Ms. Tamara Sternberg-Greller and Ms. Emily Teickenson, shared up-to-date information on entry regulations in the U.S. and provided valuable insights on the U.S. to Slovak grantees. Some of the Fulbright alumni also joined the orientation and shared their practical experience with current grantees.



**Orientation Seminar for Incoming U.S. grantees** was organized in September 2021 in order to familiarize U.S grantees with Slovak history, cultural and social background, economy, education system etc. Furthermore, a review of the terms and conditions of their grant, financial, visa, and health issues are an essential part of the orientation. A crash course on Slovak language has proven to be of importance to U.S. grantees. The Commission



annually reviews and updates the program in order to implement the guidance and protocol for a variety of possible crisis situations, diversity & equity & inclusion, mental health and well-being, and other emerging issues. The orientation is also a platform to meet and network with fellow grantees as well as representatives of the U.S. Embassy, Fulbright alumni and organizations and institutions involved in Slovak-American exchanges and relations.

Due to the COVID-19 restrictions, **Orientation for U.S. grantees coming for the Spring Term** was held on-line on February 22, 2022. Recent U.S. scholar alumni participated to meet and greet incoming grantees.



In order to provide a continuing support to our grantees, the Commission organized several zoom-calls throughout the year with current and prospective grantees, especially a Call on Ukraine on March 4, 2022 with all U.S. Fulbrighters and the PAO – Ms. Tamara Sternberg-Greller on current issues in Ukraine.

#### • The Annual Mid-Year Conference

Due to the ongoing pandemic, the annual mid-year conference was postponed from January to the end of April (April 28 – May 1, 2022). The conference took place in Trenčianske Teplice. It created the opportunity for U.S. grantees to share and exchange their experiences and present their goals and achievements as well as discuss personal and professional insights with the Commission's Staff. It provided the Commission with different perspectives on the Fulbright Program in Slovakia in order to adopt necessary changes to improve the administration of the program and support to the grantees. The conference program also reflected current sociopolitical issues and the grantees got a chance to discuss the war conflict in Ukraine with Ms. Zuzana Reptová, Fulbright Alumna, and Matej Kandrík from Stratpol.

# • The Appreciation Award Ceremony

On May 24, 2022, the Fulbright Commission prepared an award ceremony for all Fulbright grantees in the academic year 2021/2022 to appreciate the grantees for their efforts and activities during the whole academic year. The ceremony was hosted by the Deputy Chief of Mission – Mr. Nicholas Namba at the Ambassador's residence and followed by a jazz concert by Ester Wiesnerová.



#### Educational Advising

The EducationUSA Advising Center of the Commission as part of the worldwide network of the U.S. Department of State provides current, unbiased, and realistic information on study programs in the U.S., counseling on all matters connected with the U.S. educational system, U.S. standardized tests, application procedures, financial aid, visa issues, etc. to the interested public. It operates daily and provides free consulting services upon appointment.

The Center supports and trains the employees of American Corners located in public libraries in Bratislava\*, Banská Bystrica, and Košice. The centers are a common effort of the U.S. Department of State and U.S. embassies with the aim of providing better resources for people seeking information on the United States. The Center also serves U.S. partners and institutions as a source of information on Slovak and European higher education systems, e.g. verification and explanation of Slovak credentials, providing resources of information, etc.

\*American Center Bratislava, which also served as a reference EducationUSA center, was closed in March 2022 as a decision of the U.S. Embassy in Bratislava.

- On October 21, 2021, EducationUSA Slovakia was invited to talk to **29 high school students of Gymnázium Hubeného.** The event took place in the University Library in Bratislava on the topic **5 Steps to Study in the USA.** The EducationUSA adviser discussed what undergraduate studies at a U.S. university are like. Students learned more about school selection, application and admission process, and how to finance their studies. Students who were brave enough to ask a question got a small gift branded with EducationUSA and each of them got a copy of a brochure "Study in the U.S." that was published by EducationUSA Slovakia.
- Meeting with American Spaces Coordinators Fulbright Commission and EducationUSA met with American Spaces Coordinators during their annual workshop held at the U.S. Embassy in Bratislava on November 3, 2021. The Commission staff provided them with updates on Fulbright programs and the EducationUSA advisor briefed them on her participation at the EAIE conference.
- Studying in the U.S.: An Exploration of Advantages & Differences, November 18, 2021 guest lecture Zuzana Tomaš, Fulbright U.S. Scholar
- **English Teachers' Roundtable**, December 9, 2021 guest lecture Zuzana Tomaš, Fulbright U.S. Scholar, 132 registered participants.
- On March 28, 2022, EducationUSA Adviser conducted a virtual presentation to 23 high school students
  of Gymnázium sv. Edity Steinovej in Košice. The presentation was focused on study possibilities at
  universities in the U.S. It also included a short comparison of both Slovak and American school systems and
  standardized tests and the students were also presented with other options for academic exchanges.
- EAIE Community Exchange Conference Education USA Adviser Zuzana Kopčanová attended the online EAIE Community Exchange Conference that took place on September 28 October 1, 2022. It was a virtual event with more than 70 hours of live, as well as on-demand content for participants to explore. The event offered content on a variety of topics connected with international education within the European context
- Essay Writing Workshop (webinar) was held on May 25, 2022 and was co-organized by EducationUSA Slovakia, EducationUSA Czech Republic, and New York University Abu Dhabí to help students improve their essay writing skills. After the introduction to EducationUSA services in both countries, Ms. Zsuzsanna Kovács, NYUAD outreach officer provided students with brief information on New York University Abu Dhabi study opportunities and admission requirements. This was followed by the "interactive" part when students were presented with three essay prompts with possible examples to discuss what the best option is and why
- NAFSA Campus Visit University of Wyoming EducationUSA Advisor Zuzana Kopčanová was invited to join an international group of 10 EducationUSA advisors to





visit the University of Wyoming that followed the NAFSA conference (May 4-8, 2022, Laramie). During a 5-day visit, the advisers were introduced to the university's admission criteria and selection process, a brief overview of the study programs and possibilities for international students, and met the management of all university departments. They also got the chance to discover the university campus, high-tech laboratories, and sports facilities and experience some of the cultural activities for international students.

- Meeting with the coordinators of American Corner in Košice (June 23, 2022) Education USA Advisor
  Zuzana Kopčanová met with both coordinators of the American Corner in Košice. During a short meeting,
  she briefed the coordinators on the open applications for Fulbright programs, as well as updated them on
  the latest trends in international education shared during the NAFSA conference and her visit to the
  University of Wyoming.
- EducationUSA Slovakia published an updated version of the brochure "Ako na štúdium v USA". The
  booklet contains basic information on the educational system in the US, outlines and explains the major
  differences between Slovak and American education systems and helps Slovak applicants (and their
  parents) better understand the complexity of admission procedures at universities in the US.

#### • Alumni

The Commission continues to deepen the collaboration with the community of Fulbright alumni, especially with the Slovak Fulbright Alumni Association (SFAA). Fulbright alumni assist the Commission in different ways, i.e. they serve as consultants and evaluators of project proposals, participate at orientation seminars and mid-year conferences, and thus, help to promote the goals of the Fulbright Program. The Commission will also continue to encourage alumni to participate in the events and activities of the Commission. Fulbright and Humphrey alumni are also supporting the U.S. Embassy's activities with their expertise.

#### Commission-supported alumni activities:

- Ľubomír Dunaj (Fulbright Slovak Scholar Program 2019-2020) co-organized the conference HANS-HERBERT KÖGLER'S CRITICAL HERMENEUTICS. Hans-Herbert Kögler's Critical Hermeneutics, a new book edited by Ľubomír Dunaj, our #Fulbright alumnus, and by Kurt C. M. Mertel
- The Slovak Fulbright Alumni Association (SFAA) with support from the Commission and the U.S. Embassy in Bratislava, organized the second **Alumni Engagement Summit 2022** that took place in Trenčianske Teplice on June 10 12, 2022. The summit was also open to alumni of other U.S. State Department exchange programs, including the Humphrey Program and SUSIs and more than 70 alumni participated. The program was organized into 4 discussion panels covering the latest developments in Slovak society i.e., Women in Leadership, Economic Prosperity and Recovery, Education and Society, Role of Media in a Polarized Society, and Wellbeing.



#### Outreach

The core outreach and recruitment activities to attract prospective candidates of Fulbright awards rely mainly on visits to those Slovak universities outside of the capital, reaching out to audiences with different backgrounds, re-connecting with alumni from different parts of the country and promoting Fulbright opportunities for individuals, as well as institutions. Regular visits to high schools hosting ETAs are also of high importance. These visits are connected with EducationUSA outreach activities and advising services for high school students outside



of the capital. Based on the experience of the COVID-19 pandemic, online workshops remain an important part of the recruitment process, on which Fulbright alumni and/or U.S. universities representatives can participate easily.

In the academic year 2021-22 the Commission and the U.S. Embassy in Bratislava intensified mutual cooperation by participating in a series of different events organized either by the Commission or the U.S. Embassy:





#### G. ADMINISTRATION/STAFF AND FUNDING

#### 1. The Commission and the Commission's Staff

Located in the center of Bratislava, the Commission's office is easily accessible via public transportation. The Slovak Ministry of Education covers expenses for space, utilities, telephone, security, and internet connection.

**Social media** – Instagram, Facebook and LinkedIn – are crucial in communication with the interested audience. It will be used to reach out to broaden the audience, raise awareness of the Commission's activities, grantees/alumni and their impact, and the overall prestige of the Fulbright Program. The Commission's web page will remain the primary source and administrative tool for information and guidance on the Fulbright Program's opportunities and other scholarships.

Active co-operation with representatives of respective governments, partner agencies and Fulbright Commissions worldwide have become essential for maintaining the quality of operations and administration.

The knowledge and application of Slovak, European and U.S. laws is crucial for successful administration of the Fulbright Program.

The Commission staff will participate in various activities, such as professional training, seminars and conferences which focus on issues of domestic and international higher education, education at all educational levels, international policy, civil society, non-profit activities, and marketing activities.

Lýdia Tobiášová informed the Board on the Staff change as follows: **Denisa Bezáková** – Finance officer has ended her assignment with the Commission on October 31, 2022. Denisa Domaracká was hired as a new finance officer.

#### 2. Funding

Lýdia Tobiášová informed the Board on the changes in the Staff of the Commission. Financial officer - Denisa Bezáková ended her employment with the Commission on November 30, 2021. **Denisa Domaracká, Ph.D.** replaced Denisa Bezáková. Her employment started with a probationary period on November 1, 2021.

The respective fiscal year of the Fulbright Commission is observed as set by U.S. (October 1 – September 30) and Slovak (January 1 – December 31) regulations. The financial income is composed of two sources of funding: allocation from the U.S. Government and allocation from the Slovak Government.



In-kind contributions to the Commission include tuition waivers, funds allocated to other programs through other U.S. or Slovak government activities, health insurance for the grantees, private in-kind sponsorship etc.

Annually the Commission is subject to an independent audit of receipts and disbursements and on the internal control structure. The Slovak Ministry of Education, Science, Research and Sport also audits the expenses from the Slovak government contribution separately.

**Staff Training -** staff received training on social media (June 13 and June 14). Training on Piktochart and other related tools was held on August 5 and August 9, 2022.
